- Provide the wedding show with a copy of all materials and or products to be distributed at the wedding show no later then 21 days prior to the show.
- NOT TO remove any merchandise in your booth and leave your display completely intact until after the last closing of the last show and the show has been officially announced as closed. The Exhibitor also agrees to remove all exhibit merchandise from the building by final move out time, and in failure to do so, will pay for such additional costs as my incurred.
- That is the Exhibitor receives the Brides Data, the Exhibitor agrees to complete and sign the "Brides Data Release Form"
- In view of the selection, exclusive nature and the unique tie-ins involved, I fully understand and agree that this contract in firm and cannot be cancelled. Further, I agree that I shall waive any rights whatsoever, based on performance or otherwise, with regard to non-payment by me, of sums that shall be due and payable under this agreement.
